#### **Old Business:**

- Status of Audit/Audit Algorithm/Audit Committee (Kevin Hobbs)

- Strategies
  - Emphasis on what we can do (literally, what we can do) of already established events

    - Market "Spirit Wear" heavily
  - Seek new fundraising efforts
  - Communicate, communicate! Confirmation bias is our friend!
- Silver lining

  - Transition to Active Management Style
    - Opportunity to establish statistical monthly monitoring
