REPORTS AND ITEMS OF INFORMATION

1. District GCCC Representative Adam Remaly reported on opening school year activities at the Career Center including a 10% increase in student attendance for the district. New this year is the Robotics program which is housed in-district. Cosmetology and Health Sciences have seen an influx of district students.
2. Sugarcreek Education Association high school representative Julie Giles addressed the Board indicating that 17 new licensed employees have joined SEA for the current school year.
3. Representatives from Stephen Bell’s Positive Behavior Intervention Support Team, including Principal Ginger Keeton, Jennifer Huff, Rachel Barker, and Stephanie Vukovich, discussed the PBIS program. PBIS is a 3-tier based system which involves the social and emotional learning of each child and how it affects student behavior outcomes. The district focuses on teaching children about behavior expectations and strategies in order to promote school safety. Using PBIS strategies to promote positive behavior focuses on prevention, not punishment.
4. Board member Michael Kinsey discussed the additional round of Safety Grants issued to the district by the State of Ohio totaling \$200,000. The district has used these funds for improving the physical environment for staff and students including cameras and door locks.
5. Informed of a special joint meeting date set for September 19, 2022 between the school district, City officials, Township administration, and the park district regarding safety.
