MOTION 21-140 **AMENDMENT TO MASK MANDATE**

Moved by Mr. Kinsey, seconded by Mrs. Dorn to approve an amendment in the mask mandate for grades K-6 for masks to be worn in the building, right before, during, and right after school or when social distancing can't be maintained.

Roll Call: Mr. Carpenter –aye, Mrs. Dorn – aye, Mr. Kinsey – aye, Mr. Price - aye, and Mrs. Slouffman – nay. Motion carried

MOTION 21-141 **EXEMPTIONS TO MASK MANDATE**

Moved by Mr. Kinsey, seconded by Mrs. Dorn to approve an amendment in the mask mandate for grades K-6, to allow anyone to apply for an exemption if the student has a disability or has been advised by a medical professional not to wear a mask due to health reasons (documentation must be provided).
