#### **The Board heard a report or acted upon the following:**

- Approved minutes from the meetings of March 9, 2023.
- Approved the Treasurer’s Report for March 2023.
- Approved an amendment to FY 23 Permanent Appropriations to add the Expanding Opportunities federal grant.
- Approved a modification to Motion #23-25 to delete David Carpenter as Board Representative to BSEF.
- Approved 2022-2023 Blanket and Super Blanket POs.
- During Good News Recognition, President Mike Kinsey presented certificates to Cate Lensch - OATCC Indoor State Track & Field qualifier (12<sup>th</sup> place), BHS competition Cheer Squad – 2023 OASSA State Competition (3<sup>rd</sup> place), and Charlie O’Dell – 2023 SWOADA/OIAAA Athletic Director of the Year.

- Approved short-term employment contracts for Lauren Fankell & Benton Gaylor as Special Needs Assistants for the remainder of the current school year.
- Approved soliciting for National School Lunch Program Food Service Management Company Request for Proposals for the districtwide food service program beginning with the 2023-2024 school year.
- Accepted *with gratitude* a donation of a top dresser for the grassy athletic fields from Bellbrook Lions Club.
