The meeting was called to order at 7:00 p.m. by President David Carpenter.

Roll Call was taken with board members Heidi Anderson, David Carpenter, Audra Dorn, Mike Kinsey and Kevin Price in attendance.

The Board heard a report or acted upon the following:

- Approved the minutes from the meetings of April 14 & April 28, 2022.
- Approved the Treasurer’s Report for the month of April 2022.
- Approved the May update to the five-year financial forecast as presented by Treasurer Kevin Liming.
- Approved an amendment to final FY 22 appropriations bringing the total appropriations to \$39,336,535.64.
- President Carpenter read a notification from district administration regarding background check procedures.

- Approved renewal of teaching, administrative and support staff contracts, including extended service days, for the 2022-2023 school year.
- Approved Jessica Riggs as HS Winter Cheer Advisor for 2022-2023.

- Accepted a resignation from HS Engineering teacher Blake Barnes at the end of June and support staff members Joe Hamlin and Jennifer Galiardi at the end of May.
- Approved a first semester unpaid leave-of-absence for Counselor Whitney Knipfer for 2022-2023.
- Approved substitute support staff for Summer 2022.
- Approved a two-year administrative contract for Bridgett Pritchard as Director of Special Education effective August 2022.
- Approved the addition of Class 7, Technology System Analyst, to the Central Office salary scale effective with the 2022-2023 school year with placement of current employee Nathaniel Moore at Step 20.
- Approved revisions to the job description for Director of Special Education.
- Approved Student-Parent Handbooks for 2022-2023 school year for students in grades K-12.
